During troop meetings in April & May, we will learn more about Summer Camp, and begin firming up our plans. All Scouts and attending Summer Camp will be required to complete a BSA Health Form, which will be handed out later in March.*

*We'll meet at HCE (in uniform) at 8:30am on Saturday, July 14, and depart for LNC at 9:00am. We'll stop at McDonald's for lunch in Green Bay, then continue to LNC, arriving at camp approximately at 2:30pm. We'll return home the following Saturday morning, getting back to the Hales Corners area in the afternoon.*

*\*\*The cost for Summer Camp will be \$190 if paid by April 1, which includes all camping fees, meals, and most merit badges (some extra supply fees may apply). The Summer Camp fee will increase by \$10 if paid by May 17, and \$45 if paid after June 15.*
